2. The Annual General Meeting No. 1/2018 will be held on April 27, 2018 at 14.00 a.m. on the Second Floor Conference Room at the Head Office, No.64 Soi Bangna-Trad 25, Khwaeng Bangna, Khet Bangna, Bangkok 10260 to consider the following matters:
  - (1) To consider and adopt the Minutes of the Annual General Meeting of Shareholders No.1/2017
  - (2) To consider and approve the Annual Report of the Board of Directors for the Year ended December 31, 2017.
  - (3) To consider and approve the Statements of financial position and Statements of comprehensive income for the year ended December 31, 2017.
  - (4) To consider and approve the payment of dividends for the year 2017, and the appropriation of net profit to the legal reserves in accordance with the law.
  - (5) To consider the electing of new directors to replace those directors whose term have expired.
  - (6) To consider approve the Company's Directors' remuneration for the year 2018.
  - (7) To consider appointing and independent auditor including the remuneration for the year 2018.
3. The record date for the eligible shareholders who have the right to attend AGM will be on March 13, 2018.
4. The record date for the eligible shareholders who have the right to receive the dividend will be on May 8, 2018.
